## Meeting of the Candia Municipal Budget Committee Unapproved Approved Minutes November, 8th 2017

Chairman Chivers opened the meeting at 7:00pm.

Pledge of Allegiance

**Selectman Young;** Motion to accent the minutes with changes. **Jodi Hedstrom;** Seconded.

All in favor.

A matrix was provided to each Budget Committee member with regards to the town employee's budget.

Discussion ensued with regards to town employees merit raises.

Audio available for all meetings on the towns' web site.

**Chairman Chivers; Cemetery;** On the contract services line we budgeted \$2,400.00 for last year and it wasn't used, why are we budgeting for the same amount of money this year and what's the anticipated use?

Holly Haas (chairman of the cemetery committee); Holly explained that they have a lot of anticipated man hours to record records and a new software program to organize the cemetery lots.

**Chairman Chivers;** Why has the SE watershed been moved to the budget instead of continuing to be a warrant article?

**Selectman Young;** The voters voted to put it into the budget, 65% to 35% so it was put into the budget.

**Selectman Young;** The community member that usually represents Candia has not been involved so much anymore and that's why the money hasn't been taken yet this year.

**Donna Becker**; Will reach out to the SE Watershed Committee and see what they would like to do.

**Chairman Chivers; Parks and Recreation;** The park supply and repair line has been increased to \$14,000.00 will some of that be used to repair the softball fields?

**Scott Komisarek:** Yes, we allocated \$4,900.00 to do some paving and \$2,500.00 for the bathroom doors and some other continued maintenance.

**Chairman Chivers; Planning Board; Why** are we budgeting another \$10,000.00 for the Master Plan? What do you plan to do with these additional funds?

Thomas **Giffin, Chairman of the Planning Board**; ongoing effort to implement ate the master plan.

**Chairman Robbie;** He explained that we need someone to do some planning.

**Chairman Chivers;** Property Appraisal; this line has increased; we were previously told that the appraiser would be working on elderly current use and veterans exemption to be sure they were accurate?

**Selectman Young;** Our appraiser has been working on the current use files, she was not asked to work on the elderly or veterans. Some of the files have been reviewed but there are still more to do.

Discussion Ensued.

**Chairman Chivers**; Solid **Waste**; we budgeted \$1,000.00 for recycling supplies and so far none of its been used? This has increased to \$1,100.00 for next year? What are these supplies and will we be using the funds this year?

**Selectman Young;** It's for bailing wire, they had two bundles left and he'll be ordering soon. They will be expending that line before it's over. It was increased because 1,000.00 dollars wasn't enough. As I explained a lot of these department heads wait till the very end so not to go over.

**Chairman Chivers;** Town Building Expenses; How do the trustees of the Smyth building plan to use \$15,740.00 that was budgeted for this year? Will there also be a warrant article for additional funds, if so how much will the warrant article be for? What is the plan use for the money in the Smyth Memorial Building Trust and what's the current balance?

**Carla Pennfield;** Explained that there will be a warrant article for \$3500.00. The current balance in Trust is \$7,000.00, which will be used in the case of needing a new roof or whatever may come up.

Chairman Chivers; Town Office Expense; Employee merit pool was budgeted for \$10,000.00 this year and then reduced to \$5,000.00 for next year; none of these funds have been spent yet this year. Does the selectman plan to use the \$10,000.00 for this year and what's the plan for \$5,000.00 for next year?

**Selectman Young;** Believed that that was answered already.

**Selectman Young**; Passed out a down of expenses.

**Chairman Robbie;** The selectman in 2016 budget \$2,500 for a municipal resource person to come in and do our study for us. Remainder of the money will be moved to cover contract expenses.

**Chairman Chivers;** We got an email form Donna that said that on this budget there were some changes because she got some insurance figures and then there was going to be a \$65,000.00 line in the solid waste for a loader.

**Selectman Young;** It needs to be replaced. He thought he was going to get by with it, and it needs to be replaced. So we put it in the budget. It's not going to make it. Discussion ensued.

Closed to public comments.

Reviewed dates for joint meeting with the School Board. Waiting for an answer as to whether the dates work for them, School Board Rep, Stephanie Helmig will find out. Discussion ensued.
