Paul and Sarah Brassard of 266 Donovan Rd, Candia NH seek to request a 20ft right-of-way through land owned by Town of Candia, LOT#411-38, to access LOT#411-37 by way of wheeled vehicles and by foot. The grantee(s) shall have the right to maintain passable access sufficient enough to support wheeled vehicles and forest fire apparatus. Right-of-way shall be to pass at your own risk. Said right-of-way is accessible from Donovan Rd on the north eastern corner of LOT#411-40 through LOT#411-39 and continuing through LOT#411-38(subject land, owned by The Town of Candia) up to LOT#411-37. Access to said right-of-way at LOT#411-40 from Donovan Rd shall be gated. This right-of-way shall be accessible to The Town of Candia Fire Dept only for the purpose of fire training exercises, emergency medical response or response to a forest fire. This right-of-way shall remain perpetual to grantee(s) Paul and Sarah Brassard and their heirs.

ARTICLE 2.

To see if the Town will vote to raise and appropriate as an **Operating Budget**, this operating budget warrant article does not include appropriations by special warrant articles and other appropriations vote separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling **\$3,711,072**. Should this article be defeated, the default budget shall be **\$3,194,075** which is the same as last year, with certain adjustments required by previous action of the Town of Candia or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. (Recommended by the Board of Selectmen by a vote of 5-0-0)

ARTICLE 3.

To see if the Town will vote to raise and appropriate the sum of One Hundred Fifty-Three Thousand Four Hundred dollars (\$153,400) for the operating expenses of the **Smyth Public Library**. Funds are to be expended under the direction of the Smyth Public Library Association.

ARTICLE 4.

To see if the town will vote to raise and appropriate the sum of **\$20,000.00** to the Candia Youth Athletic Association for the specific expenses of providing youth recreation programs to the children of Candia. Said expenses to be expended under the direction of the Candia Youth Athletic Association Board of Directors in accordance with the approved budgets. (Submitted by petition)

To see if the Town will vote to raise and appropriate the sum of One Hundred Fifty Thousand Dollars (**\$150,000**) to be deposited into the existing **Recycle Center Equipment and Capital Improvement Capital Reserve Fund** under the provisions of RSA 35:1 adopted at the March 2017 Town Meeting, for the purpose of funding major capital improvements in the Recycling Center and the replacement of equipment used at the Center with the Selectmen appointed as agents. (Recommended by the Board of Selectmen by a vote of 5-0-0)

ARTICLE 6.

To see if the town will vote to raise and appropriate the sum of One Hundred Fifty Thousand Dollars (\$150,000) for **Excess Winter Road Maintenance**, these funds will not be used unless the operating winter maintenance funds are exhausted. This will be non-transferable appropriation. Said funds to be expended under the direction of the Board of Selectmen.

(Recommended by the Board of Selectmen by a vote of 4-0-1) (Recommended by the Budget Committee by a vote of 9-0-0)

ARTICLE 11.

To see if the Town will vote to raise and appropriate the sum of Twenty Thousand Dollars **(\$20,000)** to be placed in the existing **Revaluation Capital Reserve** fund for the Future Revaluation of the municipality. Said funds to be expended under the direction of the Board of Selectmen.

(Recommended by the Board of Selectmen by a vote of 5-0-0)

(Recommended by the Budget Committee by a vote of 9-0-0)

ARTICLE 12.

To see if the Town will vote to raise and appropriate the sum of Four Thousand Dollars **(\$4,000)** for the operation and maintenance of the **Fitts Museum**. Said funds to be expended under the direction of the Trustees of the Fitts Museum. (By request of the Trustees of the Fitts Museum).

ARTICLE 13.

To see if the town will vote to raise and appropriate the sum of Two Thousand Five Hundred Dollars (\$2,500) to be placed in the existing **Town Office Building Maintenance Fund.** Said funds to be expended under the direction of the Board of Selectmen.

If adopted, the All-Veterans' Tax Credit will also be \$750.00 per year, the same amount as the Optional Veterans' Tax Credit and shall take effect for the 2023 property tax year.

If Article 16 above does not pass, then the Optional Veterans' Tax Credit and All-Veterans' Tax Credit will remain at \$500.00 per year. If readopted and approved, this article shall take effect for the 2023 property tax year.



E-Crash Equipment

The Office of Highway Safety shall be under no obligation to provide reimbursement to a grantee for equipment purchased outside of these requirements.

Final written approval must be given prior to purchases of equipment.
