Continuation Minor Subdivision Application: Sarah H Giles Revocable Trust, 112 Lane Road Candia NH 03034; Property Owner: Same; Property Location: 112 Lane Road, Candia NH 03034, Map 414 Lot 148; Intent: To subdivide into 2 lots, new lot 3.105+/- acres leaving existing home with 6.843+/- acres Neither J. Franklin, surveyor or the owner Mr. & Mrs. Giles were present. No abutters were present. Chair James called a 5 minute recess at 7:25pm to see if J. Franklin could be contacted. Granite State Future Update

A.Hall gave an overview of the June 14, 2012 meeting that was held at SNHPC office in Manchester. He said 5 other area towns were present along with the Manchester Chamber of Commerce, eight social service agencies and local businesses. He said members will have a unique opportunity to serve their communities, to listen to their neighbors, and to help build a Granite State Future along with other regions for a statewide policy. The objectives of this project are to: protect New Hampshire's unique beauty and character, identify local assets that are important to the lasting prosperity of our communities, regions and State; capitalize on and incorporate shared values and opportunities included in existing plans and research; plan for public infrastructure investment through an open and transparent process; direct capital investments toward locally identified needs

and conserve our natural, social and financial resources. A.Hall said the next meeting is in September. Chair James thanked A. Hall for the update.
