I did hear from Commissioner Cass and he and his staff reviewed the NH 43/Old Candia Road this past week and are planning to respond to the Town's request and have developed a plan to install an oversize 48" stop sign with flashing beacon for added emphasis, as well as also ensure signing is consistent with similar panels on other legs that NH 43 traffic does not stop. The Commissioner has indicated that the DOT will also look at restriping the Old Candia road approach, eliminating the exclusive left turn lane to narrow width and emphasize the stop condition. They will be responding back to the Town in writing with further discussion as needed. I will continue to monitor and please let the Board know I am willing to continue to assist in any way I can.

 - Metal valley flashings beneath the roof valley slate tiles
 - i. NOTE: Existing downspouts and downspout accessories are to remain as these have already been replaced by Master Roofers.
- Excludes removal of the wood eave trim that the copper gutter rests upon, and decorative dentil molding at the eave/soffit location. If rot is discovered, these details are to be addressed as needed only for an extra cost.
- Cover the exposed roof where slate tiles were removed (along eaves and within the roof valley) in new high temperature leak barrier membrane.
- Fabricate and install new 5" K style copper gutter inclusive of accessory products (end caps, outlets, roof straps, etc.).
- Fabricate and install new 16' copper flashing within the applicable roof valley.
- Reinstall / replace slate roof tiles. We will include replacement copper flashing bibs and compatible stainless steel and/or copper fasteners. Our quote includes up to 30 replacement slate tiles assuming some existing tiles will be salvageable for re-installation and some will not. Additional replacement tiles, if required, will be invoiced for an extra cost.
- Repair one slate tile along the rear left ridge, to the right of the chimney.
- All work related debris is to be cleaned up daily, hauled away, and responsibly disposed of.
- Copper and slate installation will include materials and workmanship techniques that comply with industry best practices and standards.
- Quoted restoration work will be performed in such a way that maintains the integrity of the current appearance of the building and its details.
