RE: Proposed Public Auction Sale of Vacant and Unused Town Owned Real Estate

This board had earlier endorsed the sale of vacant and unused town owned real estate with the proceeds designated for deposit in a capital reserve fund dedicated for the replacement of a police facility. The warrant article proposing the sale and approved by the board, however, was amended by town counsel to stipulate that the proceeds must be deposited in the unreserved fund balance and transferred to a capital reserve fund at a later date and under a separate process. Warrant article 15 passed by a 2:1 margin, (629 in favor, 314 opposed) on March 11th confirming broad public support for both the sale of surplus land and for funding the new police facility.

The purpose of this memo is to urge the board to commence action to liquidate its portfolio of vacant and unused real estate to both expand the tax base and to resurrect interest and support for the replacement of our police facility. Consider the following:

- 1. The schedule of town property on page 74 of the 2024 Town Report shows a total value of all town owned real and personal property whether or not it is being used it is being used for a municipal purpose of \$15,814,614. The value of land and personal property being used for a municipal purpose is \$12,046,614. See Schedule 1 attached.
- 2. Subtracting the value of all property used for a municipal purpose from the total value indicates the assessed value of vacant and unused land eligible for sale in the amount of \$3,768,000. (15,814,614-12,046,614) See Schedule 2 attached.

While it is impossible to predict the net proceeds from the sale of vacant and unused town real estate, simply returning the properties to private ownership will yield \$48,457.00 in annual property taxes (3,768/12.86). Any proceeds from the sale of the properties, moreover, will mitigate the cost impact of the police facility. Both results are a win for our town. I recommend this board approve action to commence this process.
