Jan. 21, 2021 Cemetery Minutes unapproved

Regular Business: Tom ran the meeting in the absence of the Chair and Vice Chair

- 1. Pledge of Allegiance see above.
- 2. Previous Minutes no quorum to approve, (Tom & Dick were absent in Nov.) will discuss in Feb. 2021.
- 3. Mo. Operational Status Report Martin reported that P. Floyd took down trees for 3K, Sexton Martin and Vice-chair Carleton and Bob Pike cut the trees up, and Bob Pike took the wood. Bookkeeper Beth will check with Donna Becker to see if the 3K was taken from 2020 budget.

Sexton Martin may just rent a stump grinder for approx. \$325 and do it himself, members will wait for approval of 2021 budget. Sexton Martin also discussed getting more gravel and loam then seed it, near the paved portion of Holbrook Cemetery.
